Dear Winter Member,

The 2016-2017 Winter Season is right around the corner! The 2016-2017 Winter Season will begin October 1, 2016 and will end April 30, 2017. Indoor Block Time will be available October 11, 2016—April 28, 2017. As in the past, two Winter Members are needed to reserve the one and a half hour blocks of time. It is helpful to designate one person as the Captain for a tennis group to organize playing times; however, Winter Members and Homeowners must still apply for their own Block Times. The cost for the 2016-2017 Winter Season is \$200 for a Single Membership and \$300 for a Family Membership. In addition to the Membership fee, there is a \$10 per play fee (per person). Members must check in and pay at the front desk prior to going out to the courts (even if it is multiple times in the same day). For the avid player(s), there is an "all you can play" fee of \$900 per member in addition to the membership fee; no additional "per play" fees would be due. Players are still required to check-in at the front desk before going out to the court.

In addition, ALL guests who play are subject to a \$15 fee, and are limited to **4 visits** in a season, after which they must become a member or may not be permitted to play. Guests are defined as non-Sea Colony owners who are local domiciled residents of Sussex County, Worcester County and Wicomico County.

New for Fall 2016 will be outdoor Pickleball! Starting October 1, 2016 and ending December 31, 2016, we will offer a Pickleball Membership for outdoor play (4 courts). This membership will be included in your 2016-2017 Winter Tennis Membership. All members must pay a \$10 per play fee each time they play. For those interested in just Pickleball, the membership fee is \$50 per person and the additional \$10 per play.

Winter Members are entitled to a 10% discount on retail items in the Pro-Shop. Winter Members (and Homeowners) are also invited to take advantage of our Private Lesson special; buy 5 privates, and get a 6th free (valid through April 30, 2017).
