Summer Membership Rules

1. Memberships to play tennis are required on a year round basis (summer, winter or both) for non-Sea Colony owners who are local domiciled residents of Sussex County, Worcester County and Wicomico County to play tennis at Sea Colony. Owner provided guest passes may not be used. Memberships are offered each season at a price determined by the Director of Tennis and the Tennis Committee. The Summer Membership starts May 8th and continues through September 30th.
2. 2020 Summer Membership prices are \$450 for an Individual and \$800 for a Family.
3. Summer members may only make outdoor court reservations starting at 10:30 am. Reservations may be made 24 hours in advance and must be made over the phone. When making reservations, all players' names must be provided. Please notify the pro shop with any changes (this will allow for contact tracing). Reservations are in 90 minute increments, starting at 7:30 am and ending at 6:00 pm. For safety concerns, NO walk-on play is permitted.
4. Summer members **MUST** be playing with a Sea Colony Homeowner if playing before 10:30 am and the Homeowner must have made a reservation.
5. Summer Members may play indoors **if available**, and reserved by a Sea Colony Homeowner and the Homeowner is on the court.
6. Locals may pay a \$15 guest fee to play up to 4 times per season. Guest fees can be credited to a membership fee. All guest fees must be paid in advance over the phone.
7. Memberships will not be prorated or transferable under any circumstances. Members will be provided a unique identifying badge, which must be presented when requested.
8. There are no summer block times.
9. Summer members receive a 10% discount in the pro shop on all items, excluding stringing.
10. Summer members may purchase a private lesson package, Buy 5 lessons, get a 6th FREE.
11. Due to safety concerns, please adhere to the Player Social Distancing Guidelines.
12. Rules are subject to change at the behest of the Sea Colony Recreation Board.
