We are pleased to again offer a winter tennis membership at Sea Colony for the 2018-2019 season. We have extended the winter membership from September 4, 2018 to May 23, 2019 which provides an enhanced opportunity to play more tennis. Sea Colony continues to invest in our world class tennis facility. You will notice a significantly upgraded parking lot, completely resurfaced hard courts, additional pickellball courts, new plans to upgrade several har-tru courts, and fences. With these enhancements, Sea Colony continues to maintain its reputation as one of the finest tennis facilities in the world. Our winter membership pricing is offered at:

Individual Membership: \$250

Family: \$400

In addition to the Membership fee, there is a \$10 per play fee (per person). For the avid player(s), there is an "all you can play" fee of \$900 per member in addition to the membership fee; no additional "per play" fees would be due

Indoor Block Time will remain the same and be available October 1, 2018—April 30, 2019. As in the past, two Winter Members are needed to reserve the one and a half hour blocks of time. It is helpful to designate one person as the Captain for a tennis group to organize playing times; however, Winter Members and Homeowners must still apply for their own Block Times. Members must check in and pay at the front desk prior to going out to the courts (even if it is multiple times in the same day). "All you can play" members are also required to check-in at the front desk before going out to the court.

ALL guests who play are subject to a \$15 fee, and are limited to **4 visits** in a season, after which they must become a member or may not be permitted to play. Guests are defined as non-Sea Colony owners who are local domiciled residents of Sussex County, Worcester County and Wicomico County.

Winter Members are entitled to a 10% discount on retail items in the Pro-Shop. Winter Members (and Homeowners) are also invited to take advantage of our Private Lesson special; buy 5 privates, and get a 6th free (valid through April 30, 2019).
